Session 201 - Substance Use: Prevention and Impact on Families and Children Tieranni Parquet,LPC, CADA Prevention & Recovery Center Cajun Room

Substance abuse not only poses significant health risks to individuals but also exerts a devastating impact on familial dynamics and the well-being of children. Session 202 - ALICE in Louisiana: Hard Choices Impacting Families and Children Sarah H. Berthelot, President and CEO, United Ways of Louisiana Gospel Room

In this session, attendees will be provided with information about the United Way ALICE (Asset Limited, Income Constrained, Employed) report and insights directly related to the well-being of families and children. ALICE represents a significant segment of our population living above the poverty line but struggling to afford basic necessities. Participants will gain valuable insights into the unique challenges faced by ALICE families and how to tailor prevention efforts to effectively support them.

Session 203 - On the Road to Safety: Ensuring Child Well-Being through Vehicle and Car Seat Safety

Bridget Gardner, RN, Trauma Program Specialist, Injury Prevention, University Medical Center New Orleans Jazz Room

This session will focus on the critical importance of vehicle and car seat safety in preventing child injuries and fatalities. Attendees will gain essential knowledge about best practices for selecting, installing, and using car seats correctly, as well as understanding the latest recommendations for keeping children safe in vehicles. Through interactive demonstrations and expert-led discussions, participants will leave equipped with practical strategies to promote child well-being on the road.

Session 204 - FINS: Understanding Status Offenders of Louisiana Zydeco Room Reshonn Saul, Louisiana Supreme Court, Judicial Program Manager for FINS

In this session participants will increase understanding about the complexities surrounding status offenses and their intersection with child abuse prevention efforts. FINS (Families in Need of Services) cases involve minors who engage in behaviors that are only considered offenses because of their age, such as truancy or running away from home. Participants will explore the unique challenges faced by status offenders in Louisiana and learn about strategies for addressing these challenges through a collaborative, trauma-informed approach. Attendees will gain valuable insights into the underlying issues contributing to status offenses and learn how to effectively support and advocate for vulnerable youth.

Session 301 (Repeated) - Understanding Brain Architecture and Trauma Corie Hebert, Ph.D., Southeast Louisiana University Cajun Room

Session 302 - Assessing Child Safety Gospel Room Etrena Gerard, Louisiana DCFS and Lacy Simms, MCSW-BACS, Louisiana DCFS

The Child Welfare Assessment and Decision-Making Model (CWADM) is a framework that the Department of Children and Family Services (DCFS) uses to assess safety and risk and the needs and strengths of children and families throughout the life of a child welfare case. CWADM ensures that DCFS and courts have the best possible information upon which to make decisions with and for families involved with DCFS. In 2022, the safety language in CWADM was incorporated into the Louisiana Children's Code (Act 272). Our presenters will unpack the variables that help determine whether a child is safe or unsafe: threats of danger to the child, the child's vulnerability to the identified threats of danger, and the caretaker's protective capacities. They will give practical examples of circumstances that help guide the type of safety plan with the family that is needed. Presenters will provide information about the ongoing assessment of safety in a Child In a Need of Care case with a focus on conditions for return and conditions for closure.

Session 303 - Building Safe Homes: Strategies for Domestic Violence and Child Abuse Prevention

The Adverse Childhood Experiences (ACEs) Study demonstrated the connection between childhood adversity and health and well-being throughout the lifespan. Increased childhood adversity is associated with an increase in the risk of adverse outcomes in physical health, mental health, and social problems. Parents have the greatest power to prevent childhood adversity, and they deserve to know more about this important driver of public health. In this workshop, participants will gain a deeper understanding of the impact of childhood adversity and discuss the importance of parental self-care in the parent-child relationship. Participants will also learn and practice some strategies that parents can use to increase resilience and protective factors for their children.

Sarah is a first-generation college graduate of the University of Louisiana at Lafayette, completing a Bachelor of Arts focused on Interpersonal and Public Communications. Sarah has received honors through the years - including being named one of Acadiana's Women Who Mean Business; recognized as Lady of the Year by the Faith House and named as one of the Top 20 under 40 by The Daily Advertiser. This month, Sarah will receive the Rising Leader Award as part of the 17th Annual Women's Leadership Conference at the University of Louisiana at Lafayette. Sarah and her husband, Jon, live in Youngsville. They are the proud parents of two children.

Rob Carlisle currently serves as the Chief Executive Officer for Child Advocacy Services. Child Advocacy Services (CAS) is a private, non-profit umbrella agency providing services through the Court Appointed Special Advocates (CASA) program, Children's Advocacy Center (CAC) Program, and other services supporting their mission to give Voice, Healing, and Security to children. Formerly the Clinical Director for Child Advocacy Services, he has provided therapeutic supervision and counseling for children and adults in a variety of settings. Rob has developed, planned, and implemented a range programs and direct service initiatives for youth in over fourteen parishes and ten Judicial Districts throughout Louisiana. In earlier capacities, he served as the Juvenile Services Director for the City Court of Hammond. He has worked in



substance abuse treatment and the juvenile justice field for over 18 years, five of those years he has been involved in the development and implementation of three juvenile drug courts resulting in national consultant duties through the National Family and Juvenile Court Judges Association. He has served as a national consultant for the National Council for Juvenile Court Judges Association. Mr. Carlisle has been instrumental in integrating various program strategies and treatment approaches for youth in a variety of contexts including judicial, non-profit, and private settings. He strives to ensure a comprehensive continuum of care and service delivery for all youth and families. He continues as an adjunct faculty member at Southeastern Louisiana University. He received his bachelor's degree and certification in education and special education as well as his master's degree in counseling from Southeastern Louisiana University in Hammond, Louisiana. Rob has two sons, Cross-18 and Cale-16.

Sheri Eastridge joined the ACEs (Adverse Childhood Experiences) Educator Program with the Louisiana Department of Health, Bureau of Family Health in 2018 as a volunteer ACE Educator, and she became the Program Coordinator in 2022. She comes to this position after 15 years in non-profit and community leadership roles, primarily in programs serving domestic violence victims and their children and families experiencing homelessness. She has extensive experience in advocacy, developing trauma-informed programming, and compliance monitoring. Ms. Eastridge has been a trainer at both the local and state level. Since 2011, she has trained thousands of professionals, law enforcement officers, civic leaders, and other community members on the impact of trauma and strategies to build resilience. She has dedicated her career to increasing awareness about the connection between childhood adversity and health and well-being throughout the lifespan.

Bridget Gardner has been a registered nurse with the world renown Charity Hospital Trauma Center, now University Medical Center, for 31 years. She is a Program Specialist for the Trauma Department and is specific in Injury Prevention. She is a 1992 graduate of Charity Hospital School of Nursing who began her career in the Emergency Department. Bridget is the Program Director for the Louisiana Passenger Safety Task Force overseeing Occupant Protection activities in 9 regions of the state, the director of the Sudden Impact Program and serves as the Emphasis Area leader for the State Young Drivers Emphasis of the Louisiana Strategic Highway Safety Plan.

Etrena Gerard is currently a Child Welfare Manager 1 in the Child Protective Services unit at the Department of Children and Family Services in State Office. She has a master's degree in criminal justice and is experienced in Child Welfare as an investigator, a supervisor of Investigations and Family Services, as well as a Child Welfare Consultant. Etrena currently works with CPS units statewide to assist in the investigation process by providing case consultation, as well as the ongoing assessment of safety.



Dr. Corie Hebert - Dr. Hebert has served as Principal Investigator of the Louisiana Child Welfare Training Academy from inception to present. She has a PhD and teaches at Southeastern University School of Social Work with over twenty years teaching experience in social work. Areas of research include foster parent engagement, training, and trauma.

Tieranni Parquet is a Licensed Professional Counselor with a wealth of knowledge and experience in the mental health field. She is passionate about removing the stigma and criminalization surrounding individuals that need mental health services. As the Clinical Director at CADA Prevention & Recovery, she strives to empower our individuals along their journey to recovery. Ensuring that individuals feel, seen, heard and respected when they seek treatment services.

Elizabeth Power, M.Ed., of Nashville, TN USA makes peoples' lives sing! Power helps folks cope with change, increase resilience, and master trauma. She is the Founder of The Trauma Informed Academy and an adjunct instructor in Psychiatry at Georgetown University Medical Center, where she teaches Trauma-Informed Medical Care. She helps people change how they respond to what has happened in their lives or the lives of those they care for. She integrates Emotional Intelligence with skills that relieve the impact of trauma, making evidence-informed work user friendly. Power is an international best-selling author and her latest book, Healer: Reducing Crises, is the first in a series bringing her work home to readers everywhere. When she's not speaking, teaching, or writing, you'll find her in her garden. Her other books also focus on helping people learn, grow and change. Whether happiness, coping with change, or healing from trauma, she's your best bet for practical ,easy to read books (and, um, she's not the Romance Writer by the same name...)!

Reshonn Saul is currently the Louisiana Supreme Court's Judicial Program Manager for the FINS Assistance Program. As program, she's responsible for maintaining and monitoring funding for 42 FINS Programs, policy implementation, analyzing data and work with Statewide Stakeholders on multiple continued projects for Louisiana. Reshonn has 13 years of experience in the field of mental health and juvenile justice. She strongly believes that every person has the ability to change if someone believes in them. Reshonn was appointed a seat on the Louisiana Children's Cabinet by Governor John Bel Edwards in 2023. She's currently the Chair of the Children's Cabinet Advisory Board and serves on multiple state boards across Louisiana. She's a grad of Mississippi Valley State University.



Lacy Simms is a Licensed Clinical Social Worker, BACS with the Department of Children and Family Services. Lacy obtained a bachelor's in social work from Southeastern Louisiana University, and she was a Title IV-E recipient. Lacy graduated from Louisiana State University with her master's degree. There Jarvis worked in the Life Skills Program for 6.5 years as a Peer Support Specialist and Advocate for the Louisiana Foster Care System. He has held the title of President for the State of Louisiana Youth Advocacy group known as LEAF for many years. Jarvis serves on the Board for the Pelican Center for Children and Families. Jarvis has served as a speaker and panelist at multiple conferences throughout Louisiana. In 2017, Jarvis participated in the Foster Youth Intern Program held at the State Capitol in Baton Rouge, LA. He gave a powerful testimony that touched all who were in attendance. From this internship experience, he was a part of the force that pushed Senate Bill 109 into place, which extended foster care to age 21 for all youth in care on their 18th birthday. This voluntary program allows the Louisiana Department of Children and Family Services (DCFS) to provide intensive services to aid youths' transition to adulthood. As President of the LEAF board, Jarvis and his peers got the opportunity to create Louisiana's first Foster Youth Bill of Rights. Jarvis has gained many awards for his hard work. Jarvis has traveled out of the country on mission trips to serve and be a beacon of happiness to others. Through it all, he strives to be a better individual by giving back to the community and being a light in the lives of vulnerable populations.

Holly Tupper is a committed advocate of survivors of human trafficking. From India to the Ukraine-Poland border, she has worked directly alongside survivors and at-risk populations, fostering holistic healing, and preventing exploitation. Holly served over four years as a CASA volunteer, gaining first-hand experience and insight into the state legal system and the practical needs of marginalized individuals. Holly's collaborative efforts, both locally and internationally, have raised awareness and built partnerships in the fight against trafficking. As the Director of Survivor Advocacy for Unbound Now in Louisiana, she oversees CSEY advocates serving survivors in the greater New Orleans and Baton Rouge areas. Holly is committed to extending the reach of survivor advocacy through Unbound Now's survivor-centered approach. Holly remains steadfast in the mission to empower survivors, contributing to Unbound Now's 12-year fight to end human trafficking in communities around the world.



D.J. Eagle Bear Vanas is an internationally acclaimed motivational storyteller whose expertise is in leadership and personal development. He is also the author of the celebrated book The Tiny Warrior: A Path to Personal Discovery & Achievement, which is printed is six countries. His latest book, Spirit on the Run, is his first novel. D.J. is a tribally enrolled member of the Odawa Nation and a former military officer. He shows organizations how to practically apply the power of the warrior spirit to perform at their best, stay resilient and thrive in tough, changing environments. For twenty years, he's delivered his dynamic programs in 49 states and overseas to over 7,000 audiences including Walt Disney, NASA, Intel Corporation and hundreds of tribal governments, communities, and schools. He's also been invited to the White House to speak – twice.
